The taking, or attempting to take, anything of value under confrontational circumstances from the control, custody, or care of another person by force or threat of force or violence and/or putting the victim in fear or immediate harm.

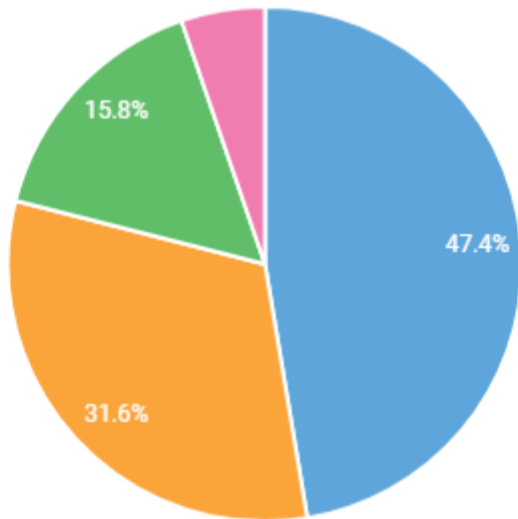

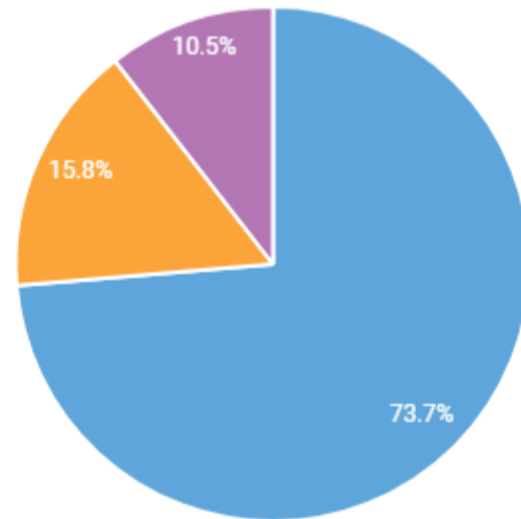
Top 5 location types for robbery offenses

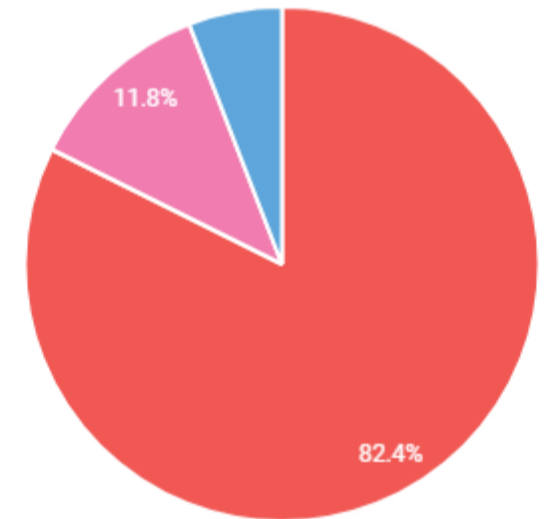
Top 5 weapons used to commit robbery

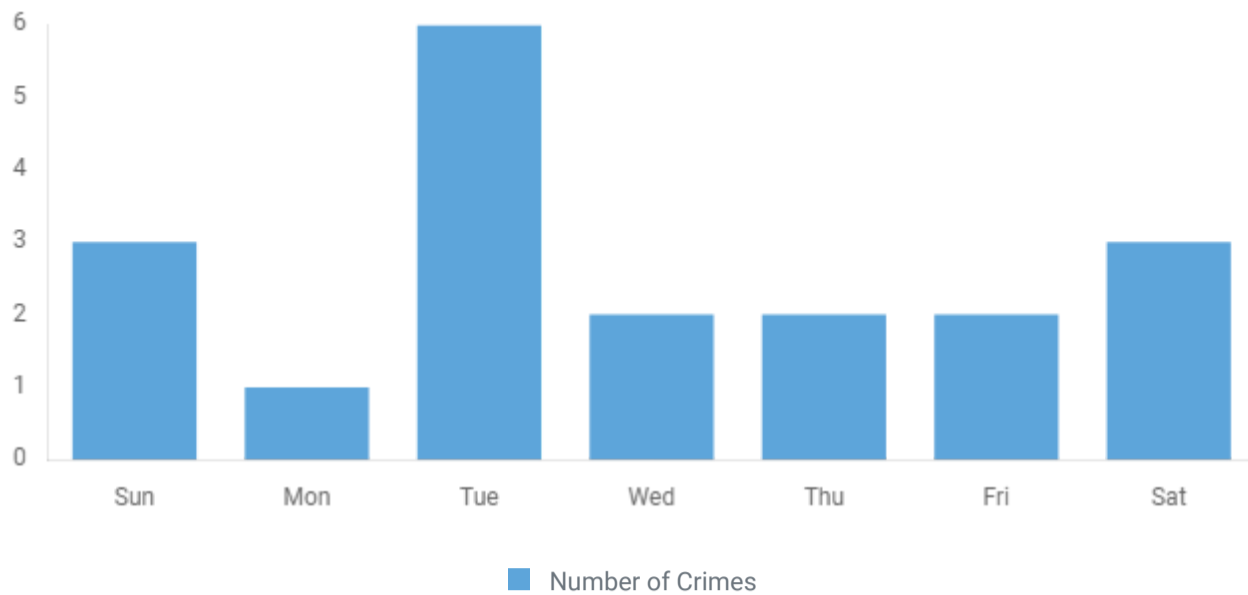

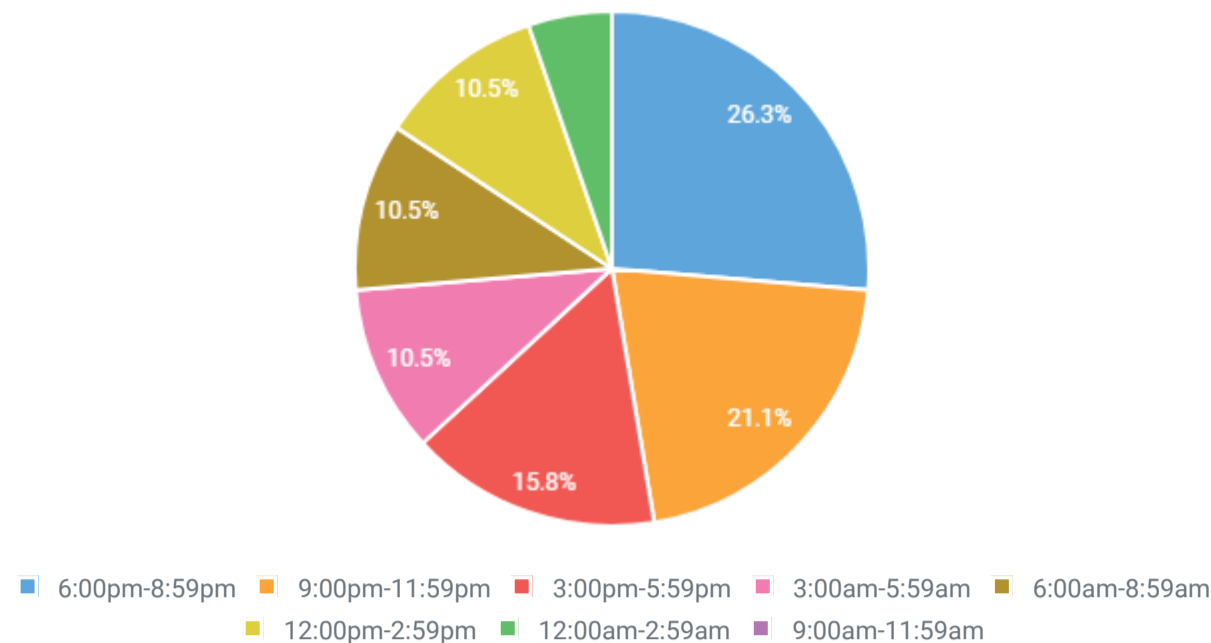

Crimes: 155 Clearance Rate: 14.84%

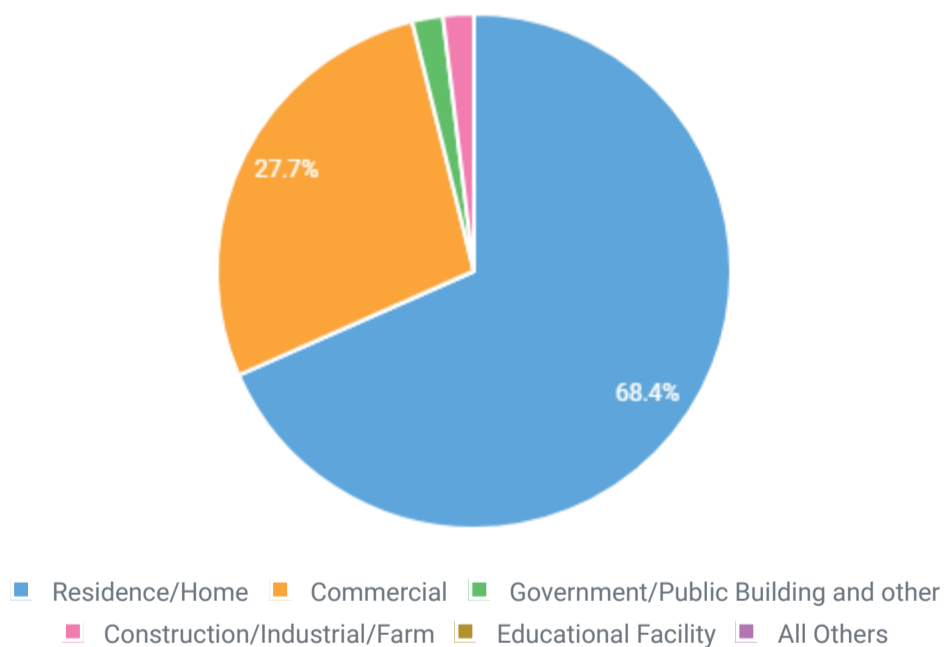

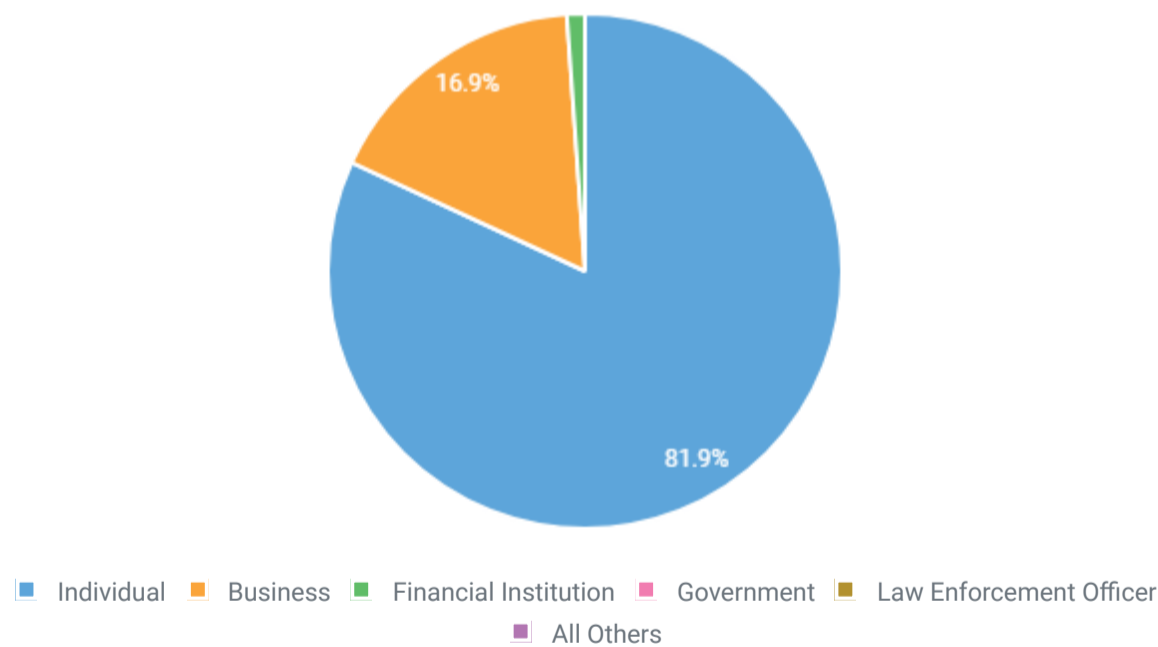

Top 5 location types for burglary offenses



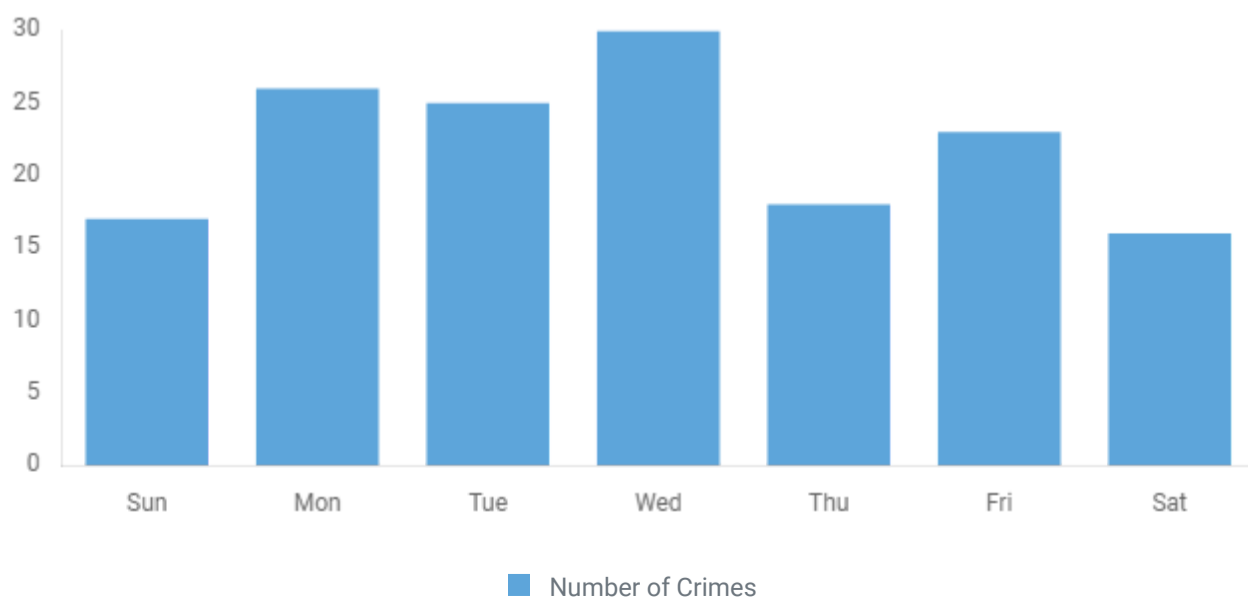

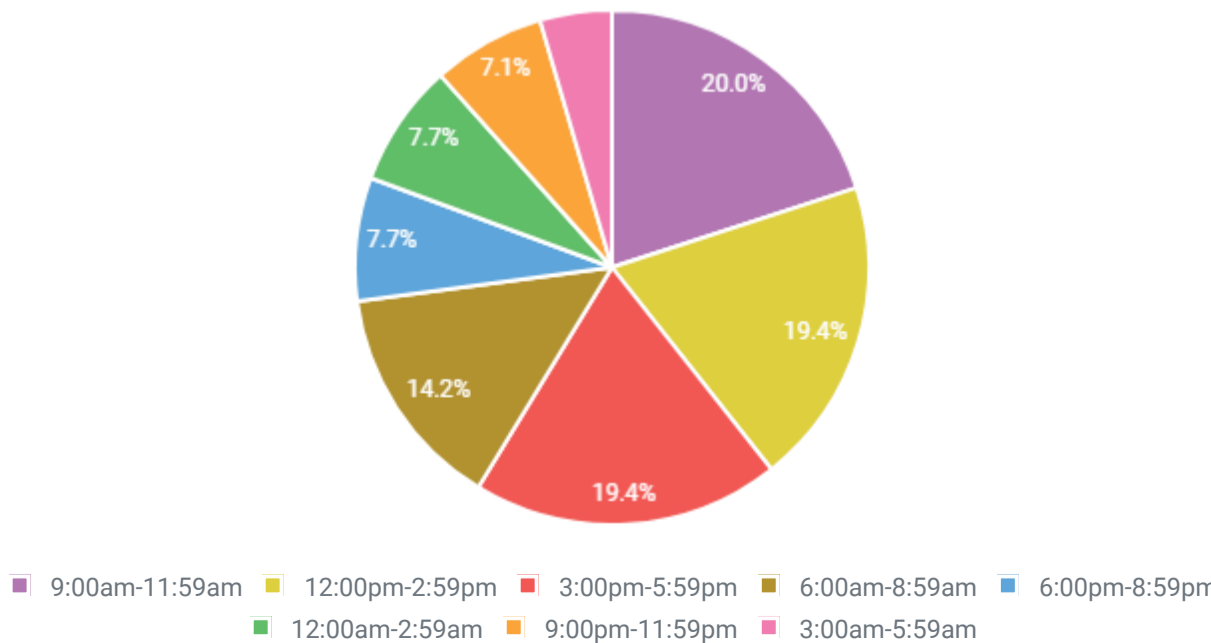

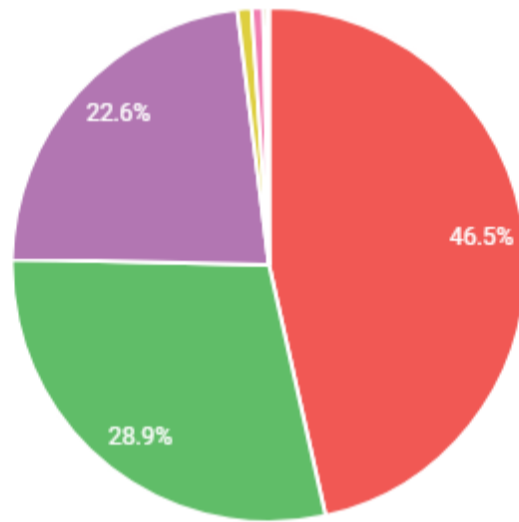

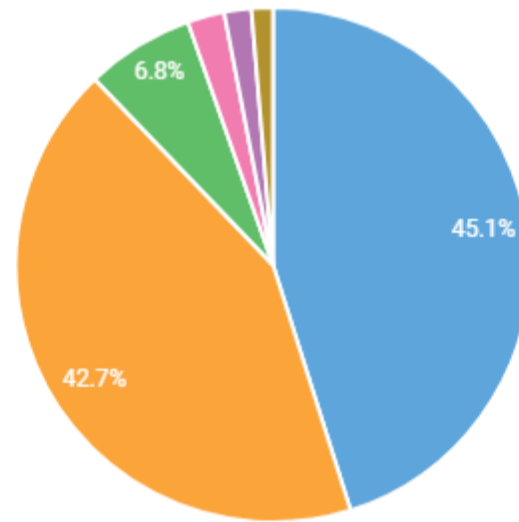

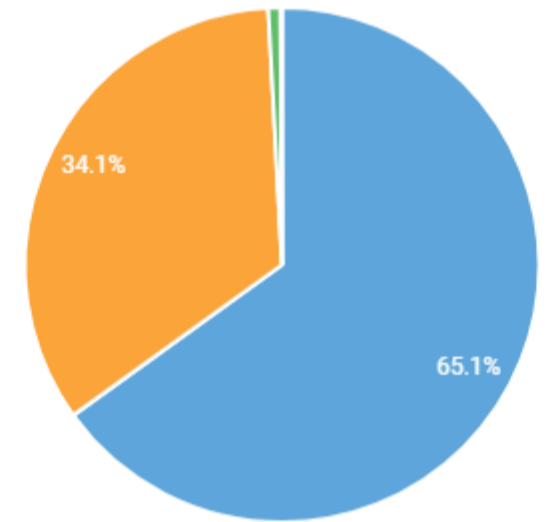

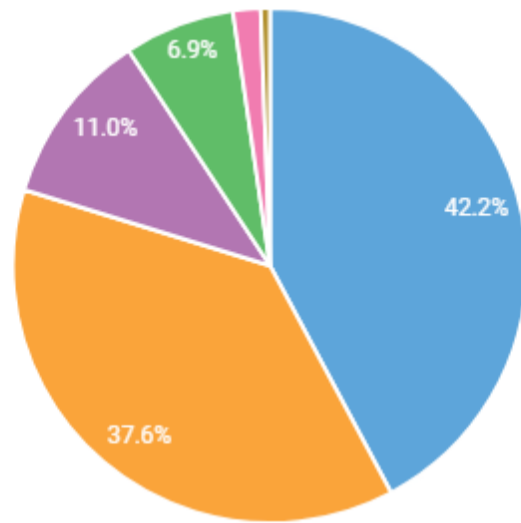

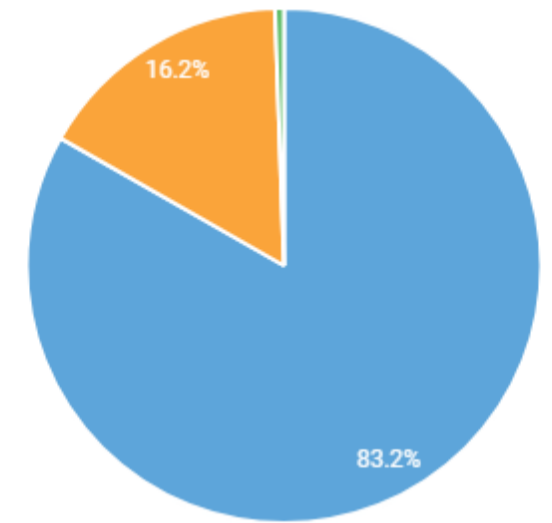
Top 5 location types for fraud offenses

Crimes: 31 Clearance Rate: 38.71%

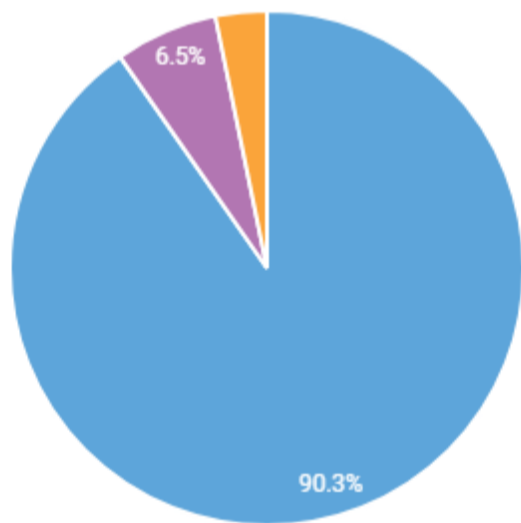

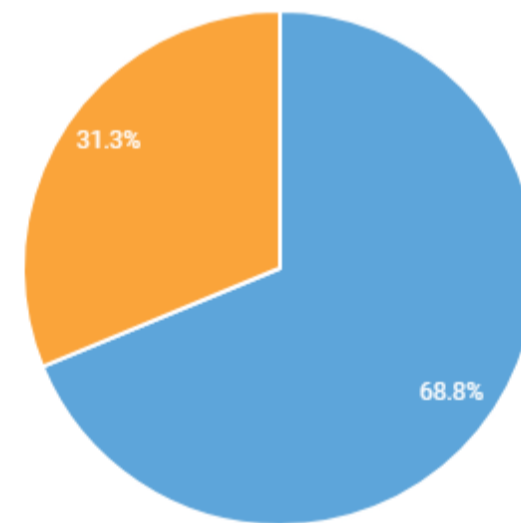

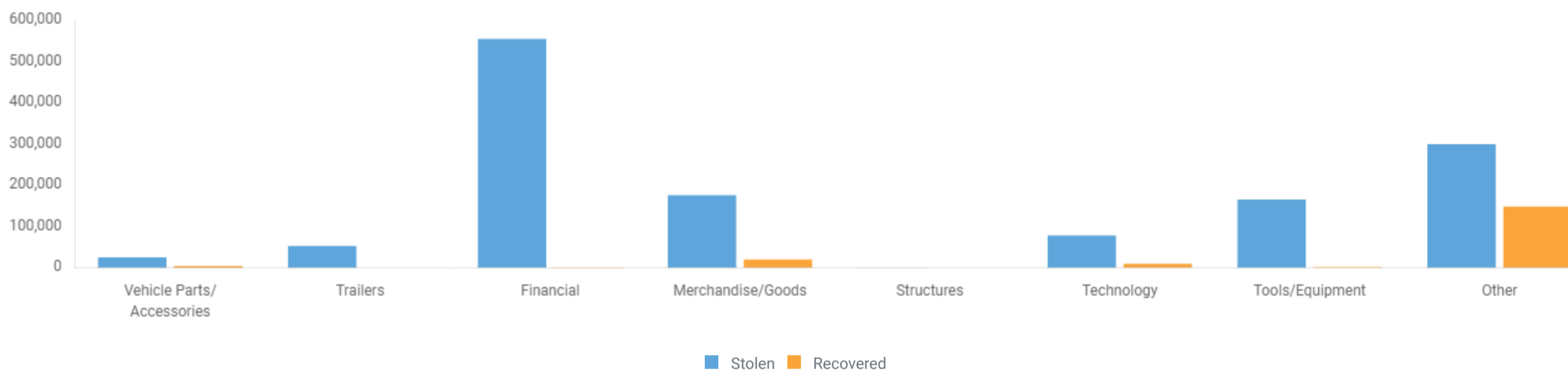

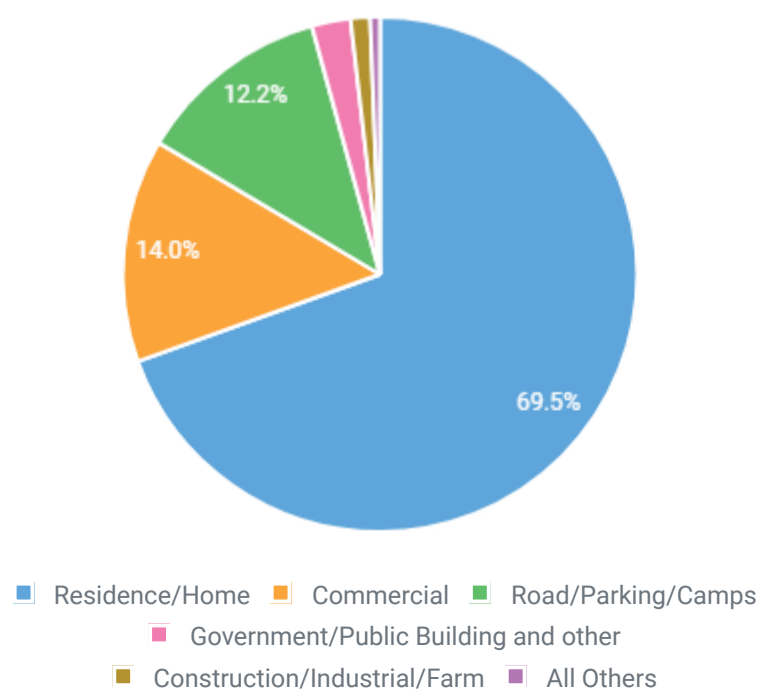

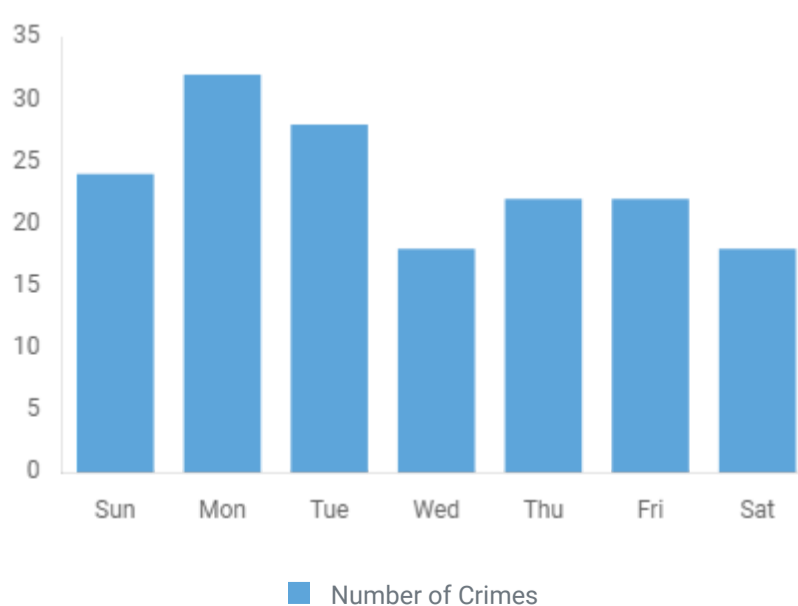

Top 5 location types for motor vehicle theft



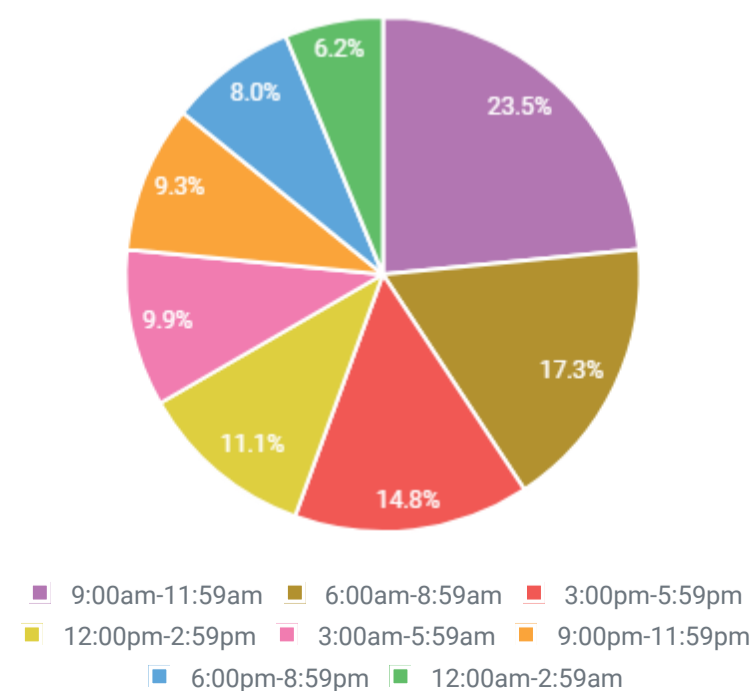

Motor Vehicle Theft



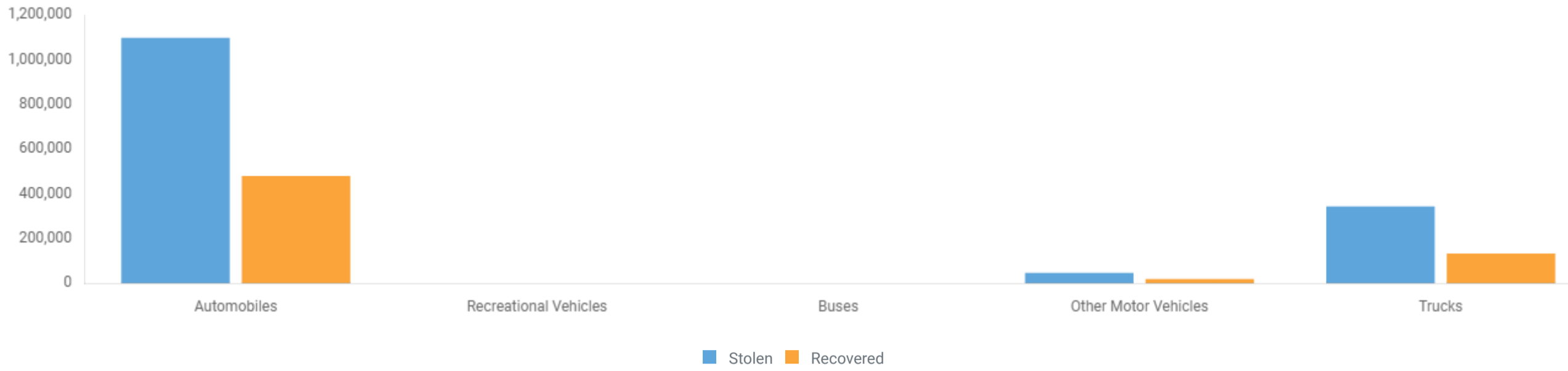
TIME OF DAY

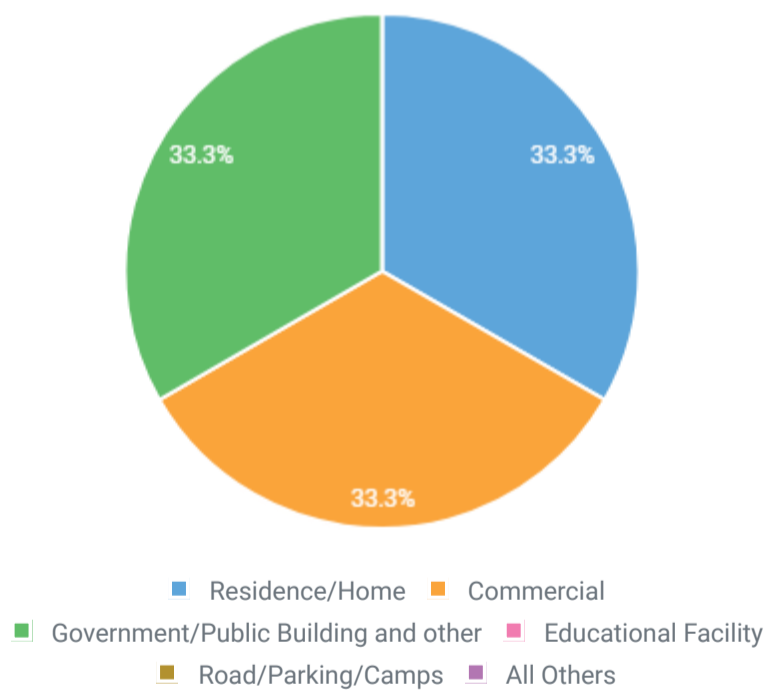

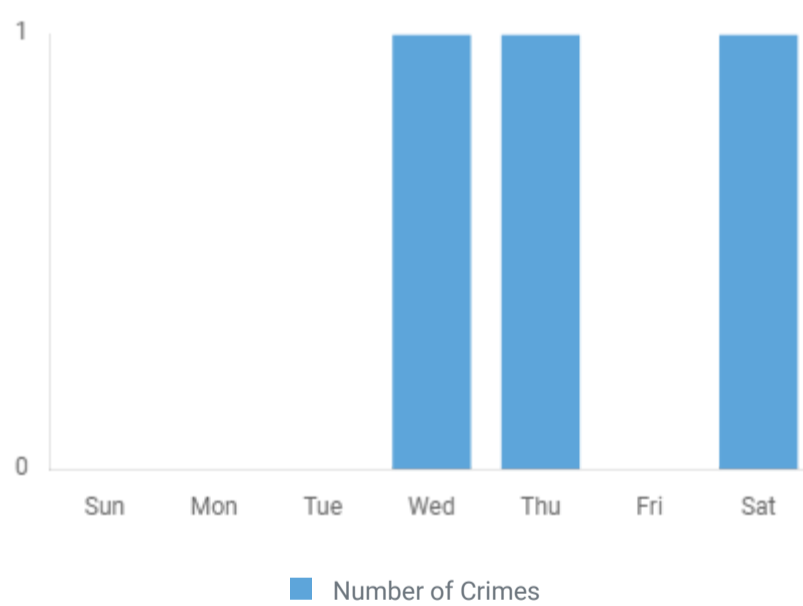

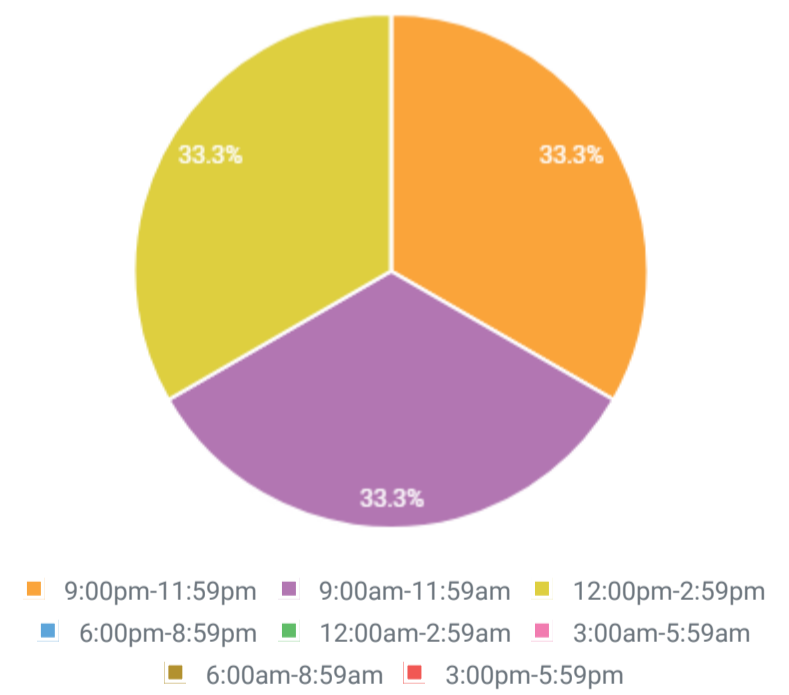
