Violent Crime consists of Murder, Non-consensual Sex Offenses, Robbery and Aggravated Assault. When counting cases below, this is the count of victims for murder, sex offenses and aggravated assault, but the count of incidents for robbery. One offense is counted for each victim.

MURDER

The willful (non-negligent) killing of one human being by another.

Crimes: 14 Clearance Rate: 85.71%

A crime is cleared one of two ways: when at least one offender is arrested; or by exceptional means, when situations beyond law enforcement's control prevent the agency from arresting the offender (for example, the death of an offender).



NON-CONSENSUAL SEX OFFENSES

Any sexual act directed against another person, without the consent of the victim, including instances where the victim is incapable of giving consent. Sex offenses include Rape, Sodomy, Sexual Assault with an Object, and Fondling.

Crimes: 120 Clearance Rate: 30%

A crime is cleared one of two ways: when at least one offender is arrested; or by exceptional means, when situations beyond law enforcement's control prevent the agency from arresting the offender (for example, the death of an offender).



* As the number of agencies reporting to the state increases, crime will appear higher, so all year-over-year comparisons should be treated with caution.







ROBBERY

The taking, or attempting to take, anything of value under confrontational circumstances from the control, custody, or care of another person by force or threat of force or violence and/or putting the victim in fear or immediate harm.

Crimes: 191 Clearance Rate: 40.84%

A crime is cleared one of two ways: when at least one offender is arrested; or by exceptional means, when situations beyond law enforcement's control prevent the agency from arresting the offender (for example, the death of an offender).



AGGRAVATED ASSAULT

An unlawful attack by one person upon another wherein the offender uses a weapon or displays it in a threatening manner, or the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness. This also includes assault with disease (as in cases when the offender is aware that he/she is infected with a deadly disease and deliberately attempts to inflict the disease by biting, spitting, etc.).

Crimes: 214 Clearance Rate: 50%
